## **The quality and standards of the early years provision**

### **The provision meets requirements**

- The childminder demonstrates a clear understanding of the learning and development requirements. She discusses that when planning play activities she would tailor them around children's individual interests and support children to move onto the next steps in their learning.
- She is clear about the requirement to carry out assessment of children and shared the systems she would use to help her monitor children's achievements.
- The childminder recognises the importance of adapting play and learning experiences to the differing children's abilities to enable all children to be included.
- Through discussion, the childminder demonstrates that she is clear about safeguarding issues and procedures. She is aware of her responsibility to promote children's health and well-being, and has a current first aid qualification.
- Through discussion, the childminder shows an understanding of the importance of working in partnership with parents and carers and other early years providers.
- The childminder has considered the different systems she can use to help her review and evaluate her childminding provision. She recognises that this will help her develop the play and learning experiences she offers to children.

## Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

- The inspector discussed with the childminder the play activities and learning experiences she will provide for children
- The inspector looked at policies and documents the provider has in place and discussed how she uses these when caring for children
- The inspector discussed with the childminder the systems she will use to evaluate the provision to help her with ongoing development.

### Information about the setting

The childminder registered in 2014. She lives with her partner in Blackwater, near Camberley, Surrey. The whole of the childminder's first floor maisonette is used for childminding. Outdoor play is provided by daily outings to nearby parks and play areas. Access to the property is via a flight of stairs. The property is close to local schools, parks and amenities. The childminder is registered on the Early Years Register and both the compulsory and voluntary parts of the Childcare Register. The childminder currently has no children on roll.

## Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
