The quality and standards of the early years provision

The provision meets requirements

- The premises are safe and secure. Staff demonstrate that they have clear safety procedures to reduce the risk of accidents and incidents.
- Staff show that they understand safeguarding children procedures and know what to do if they have concerns.
- There is a suitable range of resources and equipment. Staff demonstrate that they can plan a range of activities to reflect children's individual capabilities and interests.
- Staff explain how they support children to develop positive social skills so that they are able to play well together.
- Staff demonstrate that they encourage children to learn about healthy lifestyles, such as eating nutritious snacks and drinking more fluids in hot weather.
- Staff show that they develop positive partnerships with parents and that the club provides a valuable service. It provides good continuity for children transferring from the private nursery to the school.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

- The inspector held discussions with the manager.
- The inspector sampled documentation, including suitability checks and qualifications for staff.
- The inspector observed safety procedures on the premises.

Information about the setting

Cherubs@Wychwood registered in 2008. It is an out-of-school provision run by an adjacent private nursery. It operates from Wychwood County Primary School in the village of Shipton-under-Wychwood, Oxfordshire. It has use of a room within the school, together with a corridor area, toilets and outdoor areas. The club is registered on the Early Years Register and both the compulsory and voluntary parts of the Childcare Register. There are 51 children on roll on the Childcare Register. There are no children on roll in the early years age range as younger children currently attend out-of-school care at the private nursery. The club is open each weekday during school term times from 7.30am until 8.40am and from 3pm to 6pm. During school holidays it is open from 8am to 6pm depending on demand. If numbers are too low to provide holiday care at the school, places are made available at the private nursery. The club employs five staff, all of whom hold relevant qualifications. Of these, three staff hold level 3 qualifications and two staff hold level 2 qualifications.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
