## Summary of key findings for parents

### This provision is outstanding

- Children are highly motivated and eager to join in with a wide range of exciting activities and games that well-qualified staff teach them. This means children have great fun and develop strong friendships with each other.
- Staff know children's individual needs extremely well, so children settle very quickly and develop a strong sense of belonging at the club.
- Managers and staff have a comprehensive understanding of their roles and responsibilities to safeguard children. All staff are highly vigilant in identifying and reducing potential risk, both indoors and outdoors, so that children remain safe at all times.
- Children behave exceptionally well at the club. Staff are excellent role models to them and talk to children about behaviour expectations. This means children learn what is expected of them when playing with their friends.
- Leaders have highly effective self-evaluation systems. The managers and staff accurately identify where they can further improve children's experiences. Their commitment to improvement ensures that children benefit from outstanding provision.
- Partnerships with parents are excellent. Parents speak very highly of the club and say that the excellent staff communication means that they are fully informed of their children's activities

## What the setting needs to do to improve further

### To further improve the quality of the early years provision the provider should:

- consider how background noise can be reduced to ensure children can more clearly hear information being shared by adults.

### Inspection activities

- The inspector spoke to children and staff at appropriate times during the inspection.
- The inspector completed a joint observation with the managers.
- The inspector took into account the written views of parents provided on the day of the inspection.
- The inspector observed the activities in which children took part.
- The inspector scrutinised children's records, planning documentation, evidence of the suitability of staff to work with children, and read some policies and procedures.

## Inspection findings

### **How well the early years provision meets the needs of the range of children who attend. This is outstanding**

All staff have an excellent understanding of the Early Years Foundation Stage. They understand the importance of providing children with a club where they can relax, play and engage in exciting activities during the holidays. Staff get to know children extremely well. Children benefit from the enthusiastic approach of staff and management, who join in with games that children start. Their interaction follows children's interests exceptionally well. This means children are very happy and confident in the club and extremely well occupied. Staff value the children's views. They share their suggestions about activities so that future planning consistently incorporates children's ideas. This results in children thoroughly enjoying what they do. Children listen to each other, taking account of each other's ideas, to work as a strong team when playing together. This means children develop and practise excellent skills required at school.

### **The contribution of the early years provision to the well-being of children is outstanding**

Children settle very quickly into the relaxed atmosphere of the club. Staff use the highly effective key-person approach to support children's emotional well-being. Children develop warm relationships with staff who are friendly, caring and approachable. Children's behaviour is excellent. They follow rules and know that they must not use cameras. However, occasionally staff do not consider how background noise hinders some children's understanding of what is being explained to them. Staff use excellent daily routines to keep children safe. They teach children about playing safely so that children learn to take some supervised risks when playing. For example, they enjoy running around, taking part in games and trying to improve their physical skills.

### **The effectiveness of the leadership and management of the early years provision is outstanding**

Managers and staff have an uncompromising commitment to prioritising children's safety and welfare. There are well-documented policies and procedures that underpin the staff team's excellent practice. All staff have highly effective safeguarding knowledge. Staff recruitment procedures are meticulous. The management team ensures that all staff access supervision, training and ongoing support so that they implement procedures to a consistently very high standard. The management team makes use of their qualifications to monitor the quality of the provision carefully and has addressed the issue from the previous inspection. The changes made have helped leaders to maintain the club's exceptionally high quality so children benefit from attending an outstanding holiday club.
