## Summary of key findings for parents

### The provision does not meet requirements

- The childminder has failed to fully complete the process of submitting information to enable Ofsted to complete suitability checks for all adults living on the premises. This is also a breach of the Childcare Register requirements.
- The childminder is unclear about procedures for recording and reporting concerns about children's welfare and for sharing concerns with appropriate agencies. This is also a breach of the Childcare Register requirements.
- There is a broad range of good quality toys and equipment and adequate space is available for children to explore their interests. The childminder understands the need make observations on children to help her plan suitable activities and assess their progress.
- The childminder understands the importance of providing regular outdoor play. The childminder intends to plan frequent activities, such as nature walks and visits to the park, to promote children's health and well-being.
- The childminder understands how to provide clear guidance for children to promote good behaviour and encourage them to build positive relationships. She recognises the importance of developing partnerships with parents and others involved in children's development to provide a consistent approach to their learning.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

## What the setting needs to do to improve further

### To meet the requirements of the Early Years Foundation Stage and the Childcare Register the provider must:

The childminder registered in 1999. The childminder lives in Abbeymead, Gloucester. There were no children in the early years age group on roll at the time of the inspection. The childminder provides childcare during school holidays and before and after school.
