Summary of key findings for parents

The provision meets requirements

- The childminder understands her responsibilities to meet the learning and development requirements. She knows how to plan a range of resources and activities to promote children's learning and to help them become ready for school.
- The childminder knows the importance of monitoring children's progress. She plans to share information with parents and other settings to provide continuity of learning.
- The childminder understands the need to teach children about boundaries to support them to manage their own behaviour.
- The childminder understands how to keep children safe, such as through carrying out risk assessments and practising emergency evacuations.
- The childminder knows the local safeguarding procedures to follow should she have concerns about a child's welfare.
- The childminder recognises the importance of keeping up to date with current practice, such as through reading and research.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The childminder registered in 2010. She lives in Bexley, Kent. The childminder is available to work from Tuesday to Friday from 7am to 6pm for most of the year. There were no children on roll in the early years age range at the time of the inspection.
