Summary of key findings for parents

The provision meets requirements

- The provider has a good understanding of how to safeguard children. She is aware of how to identify and address potential hazards in the areas children use. She is also aware of the signs and symptoms that may cause concern and the reporting procedures to follow to keep children safe.
- The provider understands how to provide a range of activities, resources and opportunities for children, for example, to support their interests and needs.
- The provider keeps up to date with current childcare practices and encourages staff to keep their knowledge up to date, such as by attending training. She knows how to evaluate the provision to help identify and target areas for development.
- The provider understands how to manage children's behaviour and the need to teach them how to be kind, caring and have respect.
- The provider understands the importance of forming partnerships with parents and with other professionals, such as school teachers, to help promote consistency in children's care.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed with the provider the policies and documents she and the staff use when caring for children.
- The inspector looked at the spaces, resources and equipment available for the after school club.
- The inspector talked with the provider about how the staff meet the requirements.
- The inspector discussed self-evaluation and continuous improvement with the provider.

Limetrees Play Centre after school club registered in 2006. It is run by Ealing Play Services. It operates from Limetrees Park Children's Centre in Northolt, in the London Borough of Ealing. It is open each weekday, from 3pm to 6pm, during term time. The after-school club employs four staff, all of whom hold appropriate early years qualifications; one holds a Level 5 qualification and three at Level 3. There were no children in the early years age range on roll at the time of inspection.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the Early Years Foundation Stage.
