Summary of key findings for parents

The provision meets requirements

- The childminder understands the local safeguarding procedures and regularly refreshes her training. She knows the signs and symptoms that would cause her concern.
- The childminder recognises the importance of working with parents and other settings that children attend. She is aware that sharing information encourages consistent and complimentary teaching that helps children to make good progress in their learning.
- The childminder understands the importance of collecting the views of parents and others, to help her self-evaluate and identify areas for improvement.
- The childminder understands how to monitor children's progress from their starting points. She knows how to plan a range of interesting activities that supports children's individual learning needs.
- The childminder knows how to promote good values, such as how to behave. She understands how to help children share their thoughts and views, and appreciate other people's differences and similarities.
- The childminder understands how to promote children's good health and well-being.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector viewed the areas of the childminder's home she plans to use for children's care.
- The inspector sampled a range of documents, including policies, procedures and suitability checks.

The childminder registered in 2013. She works Monday to Friday from 6am to 7pm, all year round. The childminder holds a relevant early years qualification at level 3.
