Summary of key findings for parents

The provision meets requirements

- The provider explains how she intends to provide activities appropriate for children in the early years age range. She explains how initial information will be gathered from parents and school about children so that staff can build on children's experiences and interests.
- The provider and her staff complete training to help them understand how to keep children safe. They know how to respond if they have safeguarding concerns. Good systems are in place to help assure children's welfare.
- The provider explains how she intends to observe and assess children and share information about their achievements with parents. She describes how she will work with parents to offer support to children who may need extra help to engage in activities and will involve the school and other professionals when needed.
- The provider regularly seeks the views of parents and children and observes the practice of staff to help her review and improve the service.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector reviewed documents, including children's records and activity plans, documentation for staff, policies and registers.
- The inspector discussed with the provider how she intends to deliver the educational programmes for children and undertake observation, assessment and planning.
- The inspector discussed the safeguarding and welfare requirements with the manager and checked evidence of the suitability of staff.
- The inspector looked at the resources and areas of the after-school club that children use, inside and outdoors.

The Alpha Club @ De Lucy registered in 2013 and is one of several settings run by a private company. The Alpha Club is open 7.30am to 9am for the breakfast club and 3.30pm to 6.30pm for the after-school club during term time. The provider holds a level 3 qualification and the manager holds a level 2. One other member of staff is unqualified but working towards a qualification.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
