Introduction

The inspection was carried out by an Additional Inspector. The inspector evaluated the overall effectiveness of the school and investigated the pupils' progress in literacy and numeracy and the guidance pupils receive about reaching the next stages of their learning. Evidence was gathered from classroom visits, discussions with staff, pupils and governors as well as examination of pupils' work and school documents, especially assessment data. Other aspects of the school's work were not investigated in detail but the inspector found no evidence to suggest that the school's own assessments, as given in its self-evaluation form, were not justified and these have been included where appropriate in this report.

Description of the school

This school is smaller than most primary schools. The proportion of pupils entitled to free school meals is below average. The proportion with learning difficulties and/or disabilities is average. A very small number of pupils are from minority ethnic backgrounds. The attainment of most, but not all, children on entry to the school is below the levels normally expected, especially in communication language and literacy. A higher than average proportion of pupils enter or leave the school part way through this phase of their education and this trend is especially marked in Year 6.

Overall effectiveness of the school

Grade: 1

This is an outstanding school where all groups of pupils flourish. Pupils thoroughly enjoy coming to school. Excellent relationships with teachers help them to become confident, successful learners. The headteacher sets the tone and has played a pivotal role in developing the school's particular ethos. She has fostered a shared conviction among all staff that each and every pupil is special and is capable of exceptional achievement. Consequently everybody, staff and pupils, are encouraged to aim high. Pupils, including those who find learning difficult and those who speak English as an additional language, make excellent progress. By Year 6 standards are exceptionally high. These high standards are confirmed by the results of the national tests for pupils in Year 6. In 2007 the school's performance was exceptionally high in English and science and well above average in mathematics. Results have been consistently high over the past four years.

Teaching and learning are outstanding. Teachers and support staff love their jobs and are passionate about children's learning. Each member of the teaching force shares a commitment to exploring all avenues to promote the effective learning of each individual child. Support staff are equally committed and are particularly skilled in supporting pupils who find learning difficult. One key feature that contributes to the school's success is the meticulous way in which pupils' progress is measured and evaluated to check that all are on course to achieve the ambitious targets that are set for them. Assessment data is used to identify any pupil who is not making the progress expected and helps to target resources to support pupils who are experiencing difficulties. Some pupils who find aspects of learning hard make astonishing progress.

Pupils' personal development, including their spiritual, moral, social and cultural development, is outstanding. Pupils are brimming with confidence. They themselves say that a key strength of the school is the way in which their confidence is encouraged, 'This school is a special place because the teachers listen to us and this gives us more confidence. They never give up on us and keep trying and trying until we understand everything'. They wholeheartedly support charitable fund raising events, often organised by the highly effective school council. The eco council is also successful in promoting initiatives to conserve energy and recycle paper. Care, guidance and support are outstanding. The overarching principle that guides the work of the school is that every individual pupil will be encouraged to succeed. Each pupil is treated sensitively by staff who know exactly what approach to adopt to motivate different individuals. Pupils receive exceptionally good pastoral guidance and report that they feel safe in school. They say that they would have no hesitation in sharing any problems with staff in the certain knowledge that they would be listened to sympathetically. Pupils develop a particularly good understanding of how to lead healthy life styles. They also receive detailed academic guidance. Teachers mark work thoroughly and include good advice on how to improve. Many pupils can recite their targets in literacy and numeracy and have a clear understanding of what they need to do to reach the next stages in their learning. They are exceptionally well prepared for the next phase of their education.

Teaching and learning are outstanding. Teachers give lots of praise and encouragement. They often use interactive whiteboards exceptionally well as, for example, to project cartoons that lead pupils in singing multiplication tables with great enthusiasm and enjoyment. Pupils are bursting with enthusiasm for learning. They say that lessons are fun and that they love finding out new things. Particularly good work was seen in history. A study of the Tudors, the Plague

and the Great Fire of London provide inspiration for some powerful writing and stunning art work. The curriculum is good and is enriched by a good range of after school clubs and visits to places of interest. There is, however, scope to make further links between subjects so that the curriculum matches pupils' interests and gives them a better understanding of the inter-connection between different aspects of learning.

The leadership and management of the school are excellent. The school self-evaluation is accurate. There have been many improvements since the last inspection and the school has excellent capacity to improve further. The governing body monitors the work of the school rigorously. Governors visit classrooms, observe lessons, talk with pupils and teachers and report their findings to the headteacher. They scrutinise pupils' work and are concentrating particularly on work produced by the mixed age classes to make sure that all children in these classes are receiving equally good provision and are making good progress. The overwhelming majority of parents are pleased with the education provided for their children. One comment was typical, 'The school has a marvellous atmosphere which is noticeable as soon as one walks in. It is bright, cheerful and colourful.'

Effectiveness of the Foundation Stage

Grade: 1

Children settle happily in the Nursery where there is a strong emphasis on developing communication, language and literacy, often through structured role-play. Children enjoy acting the parts of customers and shopkeepers in the garden centre. The teacher and the nursery nurse encourage children to talk about activities such as planting seeds and to explain what they need to do to make the seeds grow successfully. Many of the new arrivals in the nursery find communication very difficult, however, and cannot easily find the words to express their thoughts clearly or confidently.

In the Reception class there is a strong emphasis on developing early reading and writing skills. The links between letters and the sounds they make are taught rigorously and this gives pupils a flying start in learning to read and write. Relationships are warm and friendly and children thoroughly enjoy their learning. They make exceptionally progress in all areas of learning, especially in their personal development. Standards by the end of the Reception year are close to national expectations.

What the school should do to improve further

- Extend the thematic approach to teaching the curriculum so that it becomes even more stimulating and engages the interests of all pupils.
